marketmania.ai ("marketmania.ai," "we," "us," or "our") values your privacy. This Privacy Policy explains what personal data we collect, how we use it, and what choices you have when using our website and services.

1) Who We Are

marketmania.ai is a subscription-based platform that helps users prepare structured market inputs for analysis by selected AI models (LLMs) and review model-generated outputs in one place. The service collects and organizes market data, selected market metrics, and (where available) market news from third-party data providers/aggregators, and supports features such as reusable presets, scheduled runs, and result delivery by email and/or Telegram (where configured by the user).

By using marketmania.ai, you acknowledge this Privacy Policy.

2) Personal Data We Collect

We collect only the personal data needed to operate the service.

- Account information (such as email address)
- Authentication data (such as password-based login data, or Google sign-in account information if you choose Google login)
- Subscription and billing metadata (such as plan, request balance, payment status, invoice/subscription identifiers)
- Preset, schedule, and delivery settings (including email and/or Telegram delivery details if you enable scheduled runs)
- Support communications (if you contact us)
- Basic technical/security data (such as IP address, login timestamps, and device/browser information used for security and service operation)

Essential technical cookies or session cookies may be used for login and core site functionality (if applicable).

3) How We Use Personal Data

We use personal data to:

- create and manage your account
- authenticate logins (including Google login, if used)
- provide core service features (including presets, scheduled runs, and result delivery)
- manage subscriptions, request limits, and add-ons
- process payments and subscription status updates
- provide support and respond to inquiries

- maintain service security, prevent abuse, and enforce usage limits
- send service-related messages (such as account, billing, delivery, or important product notices)
- occasionally send news, product updates, and promotional messages (you can opt out of marketing messages)

4) Payments (Stripe)

Payments are processed by Stripe. We do not store full payment card details.

We may receive limited payment-related information from Stripe, such as payment status, subscription status, plan information, and invoice/subscription identifiers, to operate billing and subscriptions.

5) Scheduled Delivery (Email / Telegram)

If you enable scheduled runs, marketmania.ai may use the delivery details you provide (such as email and/or Telegram destination details) to send scheduled results and related service notifications.

6) Sharing of Personal Data / Service Providers

We may share personal data with trusted service providers only as needed to operate marketmania.ai, such as providers for:

- authentication (including Google login, if used)
- payment processing (Stripe)
- email delivery
- hosting / infrastructure
- messaging or integration services used for Telegram delivery (if applicable)

7) Data Retention

We keep personal data only for as long as needed for the purposes described in this Privacy Policy, including operating the service, maintaining security, providing support, and meeting legal/accounting requirements.

In general:

- account data is kept while your account is active and for a limited period after deletion, where needed
- billing/subscription records may be kept as required by law or accounting obligations
- technical logs may be kept for a limited period for security and debugging
- support communications may be kept as needed to handle requests and maintain service records
